ArtsVote 2020 Podcast Series with Ben Folds

The Arts Action Fund launched the new podcast series "ArtsVote 2020 with BenFolds" in order to generate a national discussion with 2020 presidential candidates and political leaders about the arts, arts education, and tax policies to advance nonprofit charities in America. The Arts Action Fund has specifically invited every Presidential Candidate to have a one-on-one, 30-minute conversation with Ben Folds about their personal background and views in the arts and arts education. Candidates are encouraged to share their previous policy efforts to transform communities and states through the arts, and their vision for advancing support for the arts and the charitable sector in the future.



Ben conducts the podcast series in person or by phone with candidates and other political leaders as they travel across the country on the campaign trail. These podcasts are conversations about public policy and the arts and are not endorsements for a candidate. All podcasts are

Iowa and New Hampshire ArtsVote 2020 Forums

On August 14-15, 2019, the Arts Action Fund partnered with the lowa Cultural Coalition, the Iowa Alliance for Arts Education, Hoyt Sherman Place, and the Iowa Arts Council to present the ArtsVote 2020 Iowa Arts Forums in Des Moines and Clarina, Iowa. Advocates learned what steps they can take to ensure the arts are on the agendas of candidates and the media as campaigns set their sights on Iowa as the first-in-the-nation caucus. Iowa arts advocates were given tips to elevate the creative economy by advancing arts policy at the local, state and national levels. ArtsVote 2020 Chair and renowned musician Ben Folds led a series of live interviews with Presidential candidate Rep. Seth Mouton (D-MA) and surrogates for Governor Steve Bullock (D-MT) and Rep. Beto O'Rourke (D-TX). Interviews were streamed live on Facebook and were recorded for our podcast series at ArtsActionFund.org/podcast.

We've done similar ArtsVote 2020 events in New Hampshire by partnering with the New Hampshire Citizens for the Arts to train more New Hampshire primary voters to be highly effective in engaging Presidential candidates, and to ensure that the next President understands the value of investing in the arts. These arts advocates, like you, will help serve as our eyes, ears, and voices on the ground in early primary and caucus states.

Dear Arts Action Fund Member.

Every four years, extraordinary national media and political attention is placed on the top two presidential early primary/caucus states in the country: New Hampshire and Iowa. Both the media and presidential candidates seek to learn more about the policy issues that the residents in these states care about most in order to win their vote. As a result, an opportunity is created for advocates living in these two influential states to have meaningful discussions with presidential candidates about the arts, the needs for the future, and the economic opportunities for growth in the arts on behalf of the entire nation.

ArtsVote 2020 is a national campaign dedicated to ensuring that the arts impact national elections by encouraging candidates to take strong positions on the arts and arts education. Our goal is to create opportunities to empower members and advocates like you, especially in early primary states, such as Iowa and New Hampshire, to stand up for the arts on behalf of the entire nation. We need more arts advocates to ask presidential candidates about their positions on the arts.

We have also begun working with our local arts partners in Milwaukee and Charlotte for the 2020 Democratic and Republican National Conventions for our ArtsVote panels, where we engage delegates, artists, CEOs, and elected officials on arts and arts education policies.

Arts Advocates Meet in Minneapolis

On June 14, 2019, dozens of Arts Action Fund members gathered in Minneapolis for a fundraiser to support the Arts Action Fund PAC. At the event, we honored Rep. Betty McCollum (D-MN) with a \$5,000 PAC check (maximum possible) for her support of increased federal funding for the cultural agencies.

With the 2020 election coming up, we are vetting many candidates, as well as supporting the re-election bids for proven incumbent arts leaders looking to return to Congress. The Arts Action Fund PAC will distribute \$60,000 by the end of 2019 and, with your help, double that in 2020.

Federal Update

House Increases Federal Arts Funding Across the Board, Will Senate Follow?

The U. S. House of Representatives completed its appropriations process in July for fiscal year 2020. The House approved funding increases to every federal cultural agency and program and even included a first-time ever allocation of \$5 million for arts therapy programs in the military's budget. Specifically included in the bill is a \$12.5 million increase for both the NEA and NEH, bringing their funding levels up to \$167.5 million each. This funding level increase matches the ask we made to Congress on Arts Advocacy Day this past March.

With Congress now back in session after the August recess, the Senate has now begun

its appropriations process. Unfortunately, the Senate Subcommittee on Interior made an initial allocation of only \$157 million each to the NEA and NEH (\$10.5 million less than the House-approved level.) State and Local Update

Alaska State Council on the Arts Funding Restored!

The Alaska state legislature, during its second special session, restored funding for the Alaska State Council on the Arts (ASCA) with the governor announcing he would not veto its funding on August 19, 2019. The Alaska State Council on the Arts had officially closed its doors on July 15, 2019 after its state funding was previously vetoed by Governor Mike Dunleavy.

In his official statement, ASCA Chairman Ben Brown said, "The voices of thousands of Alaskans, and the firm and patient position taken by our funding partners, have all helped produce this wonderful result. I am especially grateful to the members of the Alaska Legislature and other elected officials and community leaders whose unwavering dedication and conviction were integral in conveying ASCA's value to the Executive Branch."

Texas Governor Approves New Funding for Arts and Military Program

Spearheaded by Texans for the Arts, Governor Greg Abbott signed the 2020-2021 state budget on June 15, 2019, adding \$250,000 in new public funding for the Texas Commission on the Arts (TCA)'s Arts Healing Grants for Active Service Members and Veterans. Also included in TCA's budget is restored funding for the Cultural Districts Project Grants, as well as a \$5 million grant to the Flower Mound Cultural Arts Commission to construct a community cultural and performing arts center.

California Arts Advocacy Impact

Arts advocates' hard work has paid off: Governor Gavin Newsom approved the FY 2019-2020 state budget on June 27, 2019, which included a \$10 million permanent increased funding allocation for the California Arts Council. This funding increase will allow the state arts council to award more arts grants to nonprofit arts organizations throughout the state.
